The Board further agrees that ethical issues regarding the Board or its members may be 5 referred to the TSBA Advisory Ethics Commission. 6 7 ARTICLE I. MY RELATIONS TO THE CHILDREN 8 9 Section 1. I will at all times think in terms of "children first," always determining other important things according to how they affect education and training of children. 10 11 Section 2. I will seek to provide equal educational opportunities for all children regardless of 12 ability, race, color, sex, creed or location of residence. 13 14 ARTICLE II. MY RELATIONS TO MY COMMUNITY 15 16 Section 1. 17 I will endeavor to appraise fairly both the present and future educational needs of the community and to support improvements as finances permit. 18 19 Section 2. 20 I will represent at all times the entire school community and refuse to represent 21 special interests or partisan politics. 22 23 Section 3. I will endeavor to keep the community informed about the progress and needs of 24 the schools. 25 ARTICLE III. MY RELATIONS TO TEACHERS AND PERSONNEL 26 27 28 Section 1. I will support the employment of those persons best qualified to serve as 29 employees and insist on a regular and impartial evaluation of all staff. 30 31 Section 2. I will support and protect personnel in performance of their duties. 32 Section 3. I will not criticize employees publicly but will make such criticism to the 33 34 Superintendent for investigation and action if necessary. 35 ARTICLE IV. MY RELATIONS WITH OTHER BOARD MEMBERS 36 37 Section 1. I will recognize that authority rests only with the Board in official meetings and 38 39 that the individual member has no legal status outside of such meetings. 40 Section 2. I will refuse to make promises as to how I will vote on a matter which should 41 42 properly come before the Board as a whole. 43 44 Section 3. I will make decisions only after full discussion of matters at a board meeting.

## 1 2 Section 4. I will respect the opinion of other members and will accept the principle of 3 "majority rule." 4 5 ARTICLE V. MY RELATIONS WITH THE SUPERINTENDENT 6 7 Section 1. I will support full administrative authority as well as responsibility for the Superintendent to properly discharge all professional duties. 8 9 10 Section 2. I will support Superintendent accountability for working and requiring staff to 11 work within the framework of policies set up by the Board. 12 I will refer all complaints and concerns to the Superintendent. 13 Section 3. 14 MY RELATIONS TO MYSELF 15 ARTICLE VI. 16 17 Section 1. I will inform myself about my duties and responsibilities and current educational issues by individual study and through participation in programs providing needed 18 information, such as those sponsored by my state and national school boards 19 20 associations.
